

END USER SOFTWARE LICENCE AGREEMENT (EULA) FOR SOFTWARE LICENCE

READ THIS END USER LICENCE AGREEMENT BEFORE INSTALLING, ACTIVATING OR USING THE SOFTWARE.

BY INSTALLING, ACTIVATING, USING OR OTHERWISE EXPRESSING YOUR AGREEMENT TO THE TERMS AND CONDITIONS CONTAINED HEREIN, YOU AS A LICENSEE CONSENT TO BE BOUND BY THIS AGREEMENT.

1. DEFINITIONS AND LICENCE

"Agreement" means this end user software licence agreement between Licensee and Licensor;

"Company" means Living Optics Limited, located at 100 Park Drive, Milton Park, Abingdon, OX14 4RY, United Kingdom;

"Documentation" means documentation associated with the Software;

"Licensed Product" means the Software and the Documentation and Protection Keys if provided;

"Licensee" or "you" means the person or organisation that originally purchased the applicable licence(s) for use with the Licensed Product from Licensor;

"Licensor" means the Company;

"Licensor Equipment" means equipment, hardware, or product purchased by Licensee from Licensor or a Licensor authorised reseller or distributor;

"Offline Licence" means a licence provided for the express purpose of authorising the use of the Software by Licensee on equipment other than Licensor Equipment;

"Protection Key" means a software-based or hardware-based activation method issued to Licensee by Licensor that authorises the use of the Software;

"Seller" means "Company";

"Software" means the computer program which is licenced to the Licensee by the Licensor in accordance with the terms of this Agreement following Licensee's purchase of a licence to use it from the Seller.

In accordance with the terms and conditions of this Agreement and in consideration of the mutual conditions contained herein, Licensor grants Licensee a non-exclusive, non-transferable licence without the right to sub-license to use the Software in object code form only in accordance with the number of licences and/or users set out in an acknowledgment of an order issued by Seller.

Product purchase documents, paper or electronic user documentation, and/or the particular licence purchased by Licensee may specify limits to Licensee's use of the Licensed Product. Fees are

dependent on Licensed Product type, and these will be determined via the Seller and paid following issuance of an invoice by the Seller.

2. LIMITATIONS OF USE

Notwithstanding the licence granted in clause 1, the licence provided herein does not permit Licensee to, and Licensee agrees not to and shall not:

- a) modify, unbundle, reverse compile, reverse engineer or create derivative works based on the Licensed Product;
- b) copy or distribute the Licensed Product, except that Licensee may produce one copy of the Software for the sole purpose of backup, as long as all copyright, confidentiality and other notices are reproduced and included on backup copies;
- c) rent, sell, lease, transfer, sub-license or grant any rights in and to any copy of the Licensed Product in any form to any third party;
- d) remove any proprietary notices, labels, or marks on or in any copy of the Licensed Product or any product in which the Software is embedded;
- e) use the Licensed Product in any manner that extends or is broader than the uses purchased by Licensee from Seller;
- f) use the Software on equipment that is not Licensor Equipment unless an Offline Licence has been purchased by Licensee, or use the Software on any equipment (including Licensor Equipment) on which the Software was not intended for use;
- g) use the Software (or make it available for use) on Licensor Equipment that Licensee did not originally purchase from Licensor or an authorised Licensor reseller or distributor;
- h) disclose results of testing or benchmarking of the Software to any third party without the prior written consent of Licensor; and
- i) use the Licensed Product in any manner other than as expressly provided herein.

3. AUDIT

Licensee shall maintain accurate records as necessary to verify compliance with this Agreement. Upon request by Licensor, Licensee shall furnish such records to Licensor and certify its compliance with this Agreement.

4. OWNERSHIP

Licensor retains ownership of all right, title and interest (including but not limited to copyright) in and to the Licensed Product, and all copies of the Licensed Product. Nothing in this Agreement constitutes a transfer or conveyance of any right, title or interest in the Licensed Product or a sale of the Licensed Product or copies of the Software.

5. THIRD PARTY SOFTWARE

Any licensor of Licensor whose software is embedded in the Software and any supplier of Licensor whose product or technology is embedded in (or services are accessed by) the Software shall be a third-party beneficiary with respect to this Agreement, and such licensor or supplier of Licensor shall have the right to enforce this Agreement in its own name as if it were Licensor. In addition, certain third-party software may be provided with the Software and is subject to the accompanying licence(s), if any, of its respective owner(s).

6. TERM

Any breach of this Agreement or failure by Licensee to pay any applicable fees due shall result in automatic termination of the licence granted herein. Upon such termination, Licensee shall return the Licensed Product to Licensor, and further destroy all backups, copies or works derived from the Licensed Product. All provisions of this Agreement relating to disclaimers of warranties, limitation of liability, remedies, or damages, and Licensor's proprietary rights shall survive termination, and Licensor shall still be entitled to all fees accrued.

7. LIMITED WARRANTY

Licensor warrants only to Licensee that the Software shall perform substantially in accordance with the accompanying documentation under normal use for a period of NINETY (90) DAYS from the purchase date. The entire and exclusive liability and remedy for breach of this limited warranty shall be at Licensor's option, either:

- (1) return of the purchase price of the Licensed Product, or
- (2) replacement or rectification of the defective Licensed Product provided a Licensor representative is granted access to the Licensed Product to perform such replacement or rectification.

EXCEPT AS PROVIDED ABOVE, THE LICENSED PRODUCT IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE LICENSED PRODUCT IS WITH LICENSEE.

LICENSEE ACKNOWLEDGES THAT IT HAS READ AND UNDERSTANDS THIS AGREEMENT AND AGREES TO BE BOUND BY ITS TERMS. LICENSEE FURTHER AGREES THAT THIS AGREEMENT CONSTITUTES THE COMPLETE AND EXCLUSIVE STATEMENT OF THE AGREEMENT BETWEEN LICENSEE AND LICENSOR, AND SUPERSEDE ANY PROPOSAL OR PRIOR AGREEMENT, ORAL OR WRITTEN, AND ANY OTHER COMMUNICATIONS RELATING TO THE SUBJECT MATTER OF THIS AGREEMENT.

The above warranty DOES NOT apply to any beta software, any software, including but not limited to the Software made available for testing or demonstration purposes, any temporary software modules or any software for which Licensor does not receive a licence fee.

8. LIMITATION OF LIABILITY

Licensor's sole obligation or liability under this Agreement is according to the limited warranty in clause 7 and shall be capped at a sum equal to the purchase price of the Licensed Product. In no event shall Licensor be liable for any loss which is or which represents loss of profit, revenue, benefit, anticipated savings, goodwill, loss of use of any asset, loss of data, business interruption, management costs, third party liability or any consequential, incidental or indirect loss arising out of or in connection with this Agreement, save that nothing in this Agreement shall limit or exclude any liability which cannot be limited or excluded in law.

9. SUPPORT

Additional support services for the Software are conditional upon Licensee executing a separate written support services agreement with Licensor.

10. EXPORT

Licensee acknowledges and agrees that the Licensed Product is subject to restrictions, laws and regulations ("Export Control Laws") and may be subject to the export laws of other countries. You agree and certify that neither the Licensed Product nor any part or direct product thereof is being or will be acquired, shipped, transferred or exported, directly or indirectly, outside the United Kingdom, the United States and/or the country in which the Software was provided to you by Licensor or an authorised distributor/reseller of the Software, or is being or will be used for any purpose prohibited by the Export Control Laws.

11. GENERAL

Any attempt to sub-license, assign or transfer any of the rights, duties or obligations hereunder is void. This Agreement shall be governed by and interpreted under the laws of England and Wales and the English courts shall have exclusive jurisdiction over settling any disputes or claims arising out of or in connection with this Agreement or its subject matter or formation.
